

1. Hiramani Higher Secondary School, Sarkhej Gandhinagar Highway, Ahmedabad-382481 has submitted its proposal for academic year 2019-20 proposing the fee structure for Std. 9 to 12 (Secondary and Higher Secondary) (GSEB Gujarati Medium) along with certain documents.
2. While going through the proposal submitted by the school, it appears that the school has filed affidavit for the academic year 2017-18 and 2018-19 and accordingly, the Fee Regulatory Committee had passed the orders determining the fees on the basis of the affidavit so filed. The only reason for filing this proposal for the academic year 2019-20 is that the fees proposed by the school are little high than the cut off limit fixed by the State Government. While examining the projected income and expenditure accounts for the academic year 2018-19, it appears that the total expenditure during the academic year 2018-19 was Rs.1,36,83,124/- and strength of the students in the academic year 2018-19 was 484. If the total expenses are divided by number of students, the cost per student would come to Rs.28,270/-. As against this cost, the school has collected fees of Rs.23,170/- in secondary and Rs.24,150/- in Higher Secondary (General) and





Rs.26,450/- in Higher Secondary (Science). The school has now proposed fees for the academic year 2019-20 by adding 10% in the fees collected for the academic year 2018-19. The fees proposed by the school for the academic year 2019-20 are little high than the cut off limit fixed by the State Government. However, considering the cost per student of Rs.28,270/-, the fees proposed by the school at Rs.25,487/- for secondary and Rs.26,565/- for higher secondary (General) appear to be quite reasonable and hence, the same are hereby provisionally approved. As far as Higher Secondary (Science) is concerned, though the fees proposed by the school are Rs.29,095/- which are more than the cost per student, the cut off limit fixed by the State Government is Rs.30,000/- and since the fees proposed by the school are within the cut off limit, the same are hereby approved. Accordingly, provisional fees determined by the committee for Secondary and Higher Secondary Standard (GSEB Gujarati Medium) are as under:

6. The school is directed to place the order determining provisional fees on its notice board as well as on its website.



Rs.27,000/- in Higher Secondary (Science). The school has now proposed fees for the academic year 2019-20 by adding 10% in the fees collected for the academic year 2018-19. 
