1. HIRAMANI SHISHUMANDIR AND HIRAMANI PRATHAMIK SHALA, Chharodi, Ahmedabad Self Financed School management made the proposal under Rule-6 of Gujarat Self Financed Schools (Regulation of Fees) Rules – 2017, in Form - II on 24.05.2017 hearing was held before the previous committee as per for the provision of Rule – 7 of Gujarat Self Financed Schools (Regulation of fees) Rules – 2017
2. Consent letter, Dated 31.01.2018, was produced by School management during hearing on 31.01.2018.
3. The meeting of the Fee Regulatory Committee is held today at 11:00 a.m. to consider the provisional fees for the year 2017-18. In all about 42 cases, wherein, the Schools have already submitted their proposals and hearing were also taken place before the previous Committee, Almost all these Schools have filed their consent letters having agreed before the previous Committee in the month of January, 2018 and having stated therein that they have no objection if the fees in their cases are determined as per their consent letters as against the fees proposed by them in their proposals for the year 2017-18, with 5% rise for the year 2018-19 and 2019-20. This Committee could have taken the final decision in respect of all these schools and final fees could have been determined for the year 2017-18 on the basis of their consent letters subject to minor variations depending upon the facts of the individual cases. However, the committee has not adopted this course in view of the decision of the Hon'ble Supreme Court dated 1.2.2018 and 19.2.2018 in Special Leave to Appeal (c) No. 314/2018 and other allied matters. The Committee therefore decides the provisional fees for the year 2017-18 on the basis of the proposals submitted by them as well as consent letters filed before the Committee, with minor variations with 5% rise for the provisional fees for the year 2018-19 and 2019-20.
4. In exercise of the powers conferred under the Gujarat Self Financed Schools (Regulation of Fees) Act and Rules framed there under in 2017 the Committee has considered the proposal along with documents submitted and the consent letter filed and accordingly provisional fees for the year 2017-18 is determined with 5% rise therein for the year 2018-19 and 2019-20 as under

2. It is also made clear that no School is permitted to collect more fees for the remaining quarters of 2017-18, if any, more than provisional fees determined by this Committee and if any excess fees collected by any of these schools the same shall have to be refunded to the students.
3. It is further made clear that no school is permitted to collect fees under any other head including under the head Admission fees or term fees and there by causing any extra burden on the students.
4. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
5. This provisional fees determined by the Committee shall be subject to the final determination made by the Committee, after considering the objections received by the committee, if any and as may be altered amended or modified either by the Fees Revision Committee or by the Hon'ble Supreme Court of india in appropriate proceedings.


